Welcome once again to the Migration Monitor – your quarterly ISO 20022 Industry Migration Program newsletter. Each quarter, we provide a high-level update on where the Program is up to and where we are headed. We are now live! On Monday, 20 March 2023, the Australian HVCS, like CBPR+, Payments Canada, New Zealand, and ECB's TARGET2, went live with ISO 20022 messaging. This huge milestone marks the end of Phase 1 activities. In this edition of the Monitor, we recap on what that means, wrap up Phase 1, and dive into Phase 2 activities.

FROM THE PROGRAM DIRECTOR...

Congratulations to our 50 HVCS Participants on reaching the amazing milestone on 20 March 2023, of Go Live for ISO 20022 in the MX HVCS Closed User Group.

In the first week of operation we saw around 26% of HVCS traffic volume processed as MX messages.

The beginning of our Migration Program certainly feels like a long time ago now, starting with the consultation by the RBA back in 2019. In February 2020, the RBA published its conclusions, setting the path for the industry's migration to ISO 20022 and appointing AusPayNet as the central coordination authority for the Migration Program.

Undoubtedly, this has been the largest and most complex program of work AusPayNet has ever undertaken in-house.

Even though we didn't get to go live last November, all 50 of our HVCS Participants were fully tested, certified and read to go on time. A rare feat, considering that this type of large-scale whole-of-industry initiative is notoriously difficult to deliver successfully.

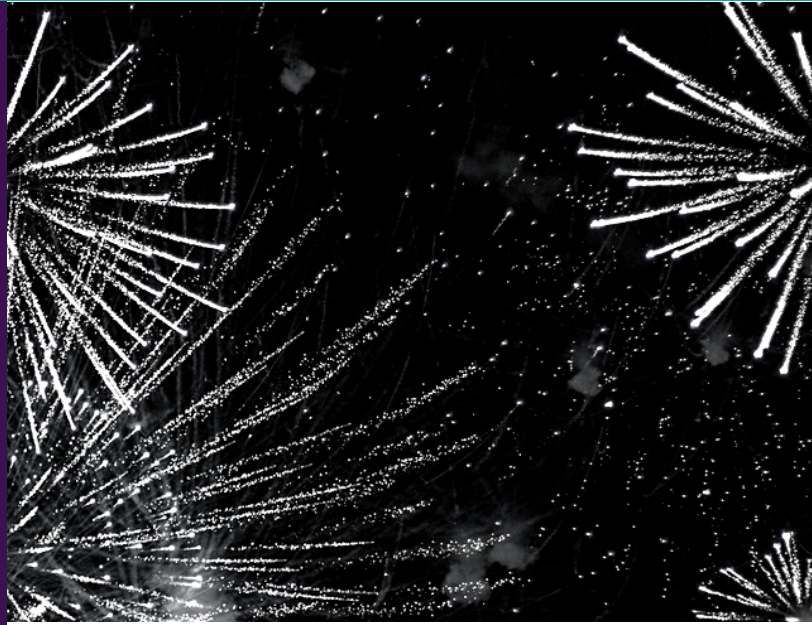
I commend all of our HVCS Participants on their dedication, spirit of mutual support and cooperation, in helping their fellow Participants. Collaboration has been crucial to our success.

The strategic significance of this migration must be acknowledged. We are creating a platform ready to meet the future needs of Australia's payments system and the global payments community.

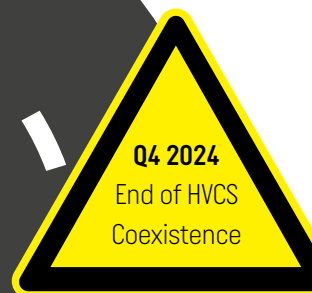

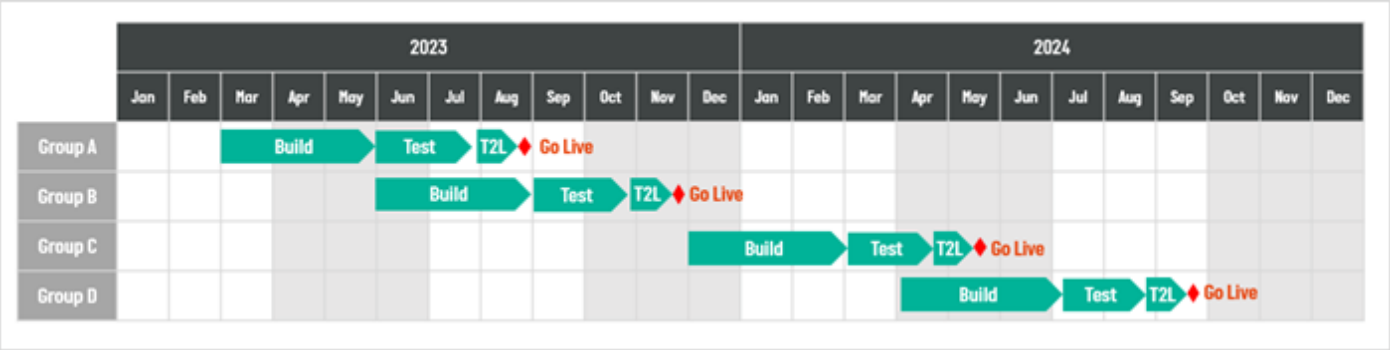

IMPLEMENTATION WORKSTREAM

An Implementation Framework has been agreed that forms a repeatable cycle to be used for each implementation group. Each cycle will cover planning, build, test and transition to live over a six month cycle.

The schedules for each instance of the framework are shown in the graphic above.

All Participants will nominate which group or groups they will join to implement their remaining ISO 20022 send-functionality, including exception and investigation messages.

This means all HVCS Participants will complete their migration to ISO 20022 for all HVCS messaging before the end of Coexistence.

Group A has already been formed and locked in its schedule.

STRUCTURED DATA WORKSTREAM

Market Practice will be developed for each of the following topics through a series of Participant workshops.

- LEI (Legal Entity Identifiers)
- Purpose Codes
- Structured Remittance
- Structured Address
- Other Topics
- Adoption Planning

The first topic was Legal Entity Identifiers (LEIs). LEIs support faster and more accurate identification of parties involved in a payment chain which will bring efficiencies when processing cross border payments. This aligns with the G20 objectives to provide faster, cheaper and more transparent cross border payments.

Adoption planning, which will include consideration of timelines, lead times, adoption tracking and solutions to adoption challenges, will also be covered off for each topic.

The draft LEI market practice, at a high level, proposes a mandatory use of LEI (where it is available) in some parts of the message, recommended use of LEI (where it is available) in other parts of the message, and some considerations regarding message translation and managing inconsistent or conflicting information.

The draft market practice also encourages promotion of the adoption of LEIs by corporates.

After each set of market practice goes through the required approval steps, it will be presented to all Participants to ensure they remain fully informed. Some information will also be made publicly available, and Participants will be free to brief their vendors and customers on requirements and plans for adoption.
